### 'DATA SUBJECT PERSONAL DATA APPLICATION FORM'

#### GENERAL EXPLANATIONS

According to the provisions of the Law No. 6698 on Protection of Personal Data (the "KVK Law"), you, as Data Subject, i.e. as the "Related Person" pursuant to the definition in the aforementioned Law (but as hereinafter referred to as the "Applicant"), are entitled to:

- get detailed information about your rights on protection of your personal data,
- learn whether your personal data are processed or not,
- request information if your personal data are processed,
- learn the purpose of processing of your personal data and whether they are used for the intended purposes,
- learn whether your personal data are transferred or not, and if transferred, the third party(ies) to whom they are transferred to,
- request the rectification of any incomplete or inaccurate personal data, if any;
- request the erasure or destruction of your personal data under such conditions as laid down in the applicable legislation,
- request the notification of your aforementioned requests for rectification, erasure or destruction of your personal data to such third party(ies) to whom your personal data are transferred to,
- request compensation for any damage, if any, arising from any unlawful processing of your personal data.

For making usage of the above rights as granted by the aforementioned Law, the following procedure shall be employed for any applications to be made to our Company as Data Controller:

#### Application Procedure

For any application to our Company, the hereby 'Data Subject Personal Data Application Form' is required, after having been completely filled in, to be

- submitted by the Applicant in person to our Company in printed out hardcopy format; or
- served by notary public to our Company in printed out hardcopy format; or
- forwarded to our Company's Registered Electronic e-Mail Address in electronic softcopy format under Applicant's "safe electronic signature" as defined in the Law No. 5070 on Electronic Signature.

Please find below, depending on the modus of application, the physical and virtual addresses where the 'Data Subject Personal Data Application Form' is to be submitted or served in printed out hardcopy format or to be forwarded in electronic softcopy format, as well as the information to be given thereby:
